PRESENTATIONS

University of La Verne Women's Volleyball - The 2025 University of La Verne women’s volleyball team delivered one of the most remarkable seasons in program history, finishing 30–3 overall and 15–1 in SCIAC while earning the No. 1 national ranking for seven consecutive weeks and remaining in the Top 10 all season. The Leopards captured the SCIAC Regular Season Championship and were led by Head Coach Jeff Hendershot, who surpassed 100 career wins and was honored, along with his staff, as SCIAC Coaching Staff of the Year. National accolades followed, highlighted by Mya Ray being named NCAA Division III National Player of the Year and becoming the program’s first 2,000-kill athlete, alongside multiple All-American and All-Region selections. In the postseason, La Verne claimed the Regional Championship, advanced through the Elite Eight and Final Four, and returned to the NCAA National Championship match for the first time since 2008, finishing as the 2025 National Runner-Up. With 30 wins, record-breaking performances, and a return to the national stage, the Leopards didn’t just make history — they launched a new era of La Verne volleyball.

The City Council of the City of La Verne, having on December 16, 2025 completed the hearing on the appeal of Richard Espinoza, II (“Espinoza”) to the Hearing Findings and Decision of County of Los Angeles Department of Animal Care and Control Executive Assistant, Harold W. Homes, Esq., dated September 29, 2025, hereby makes the following Findings and Determination.

I. Background Facts.

On August 21, 2025, Espinoza’ dogs “Rhianna” and “Phat Girl” were impounded from his residence at 816 Lake Avenue, La Verne, California 91750 by the Inland Valley Humane Society (“IVHS”). IVHS sought a Vicious Dog declaration for “Rhianna” and a Potentially Dangerous Dog declaration for “Phat Girl.” Espinoza requested a hearing. Subsequently, IVHS also sought Potentially Dangerous Dog declarations for Espinoza’s dogs “Gilligan” and “Zeus.” A hearing was held beginning on September 9, 2025, continuing on September 15, 2025, and concluding on September 29, 2025. The hearing included substantial testimony from witnesses, investigators and Espinoza. The testimony is described thoroughly in the Hearing Findings and Decision dated September 29, 2025, so we do not repeat it here.

After hearing and considering all the testimony and evidence, the hearing officer determined that IVHS had established the following facts:

1. "Rhianna" bit Ryan RUSSELL ON April 24, 2025, causing a severe injury, bit Chloe ARP:A on August 18, 2025, causing a severe injury, and bit Tristan AROLA on an unknown date in September 2024.
2. "Phat Girl" bit Ryan RUSSELL on April 24, 2025, bit Kaylie AROLA ON August 18, 2025, and demonstrated a propensity, tendency or disposition to attack unprovoked, to cause injury, or to otherwise threaten the safety of human beings on August 18, 2025.
3. "Gilligan" demonstrated a propensity, tendency or disposition to attack unprovoked, to cause injury, or to otherwise threaten the safety of human beings on April 24, 2025, and bit Kaylie AROLA on August 18, 2025.
4. "Zeus" demonstrated a propensity, tendency or disposition to attack unprovoked, to cause injury, or to otherwise threaten the safety of human beings on April 24, 2025, and August 18, 2025.

The hearing officer therefore declared Rhianna to be a Vicious Dog and ordered her to be humanely euthanized. Phat Girl, Gilligan and Zeus were each declared to be a Potentially Dangerous Dog, and the hearing officer imposed terms and conditions for their continued ownership and maintenance. IVHS has retained custody of Rhianna and Phat Girl pending appeal and/or compliance with the order. Portions of the order were stayed pending appeal.

Espinoza appealed the hearing officer's decision to the La Verne City Council pursuant to the terms of La Verne Municipal Code section 6.25.050. Espinoza was duly notified that the appeal would be heard at a special meeting of the City Council to be held on December 16, 2025.

II. The Appeal Hearing.

The meeting was called to order by Mayor Hepburn. Mayor Pro Tem Kashifalghita, and Council

Members Crosby and Johnson were also in attendance. Council Member Lau was absent. The Mayor advised the parties that they had been provided with all evidence previously submitted, as well as the written decision of the hearing officer in advance of the appeal hearing and all members had read the information. He stated the rules for the hearing, including time limits for public comment, and the presentation of evidence and argument. Espinoza appeared at the Appeal Hearing on his own behalf. All witnesses were sworn by the Deputy City Clerk. Public comment was permitted on the matter in accordance with the requirements of the Brown Act. Espinoza was given fifteen (15) minutes to present his evidence and argument in support of his appeal. IVHS was given fifteen (15) minutes to present its evidence and argument in support of the hearing officer's decision. Espinoza was then given an additional five (5) minutes to rebut any of IVHS's evidence and closing argument.

A. Mr. Espinoza's Case.

Mr. Espinoza provided both testimony and argument during his initial presentation. He did not provide any additional evidence which the Council found relevant to its decision. In sum, he offered multiple print outs from Google AI and the ASPCA website referencing dogs' responses to persons using methamphetamines and fentanyl, heroin, psilocybin mushrooms, marijuana, so-called "bath salts," metabolism rates for alcohol and marijuana and factors affecting the rates, detection of THC metabolites and alcohol through testing, undated printouts of news articles, one including a date of April 22, 2015, a copy of a post from October 2024 including a family photo of Valerie Espinoza's family, including two of the children who were bitten, copies of a declaration from his mother and co-owner of the dogs, Virginia Espinoza dated September 5, 2025, which appears to have been submitted during the underlying hearing, as was Espinoza's of the same date (Exhibit 38); however, we cannot ascertain from the record whether it was admitted into evidence or if it was given an exhibit number¹. The Google AI and ASPCA website printouts were not admitted into evidence as they are irrelevant to these

¹ Virginia Espinoza was present at the underlying hearing but did not testify.

proceedings, particularly since Espinoza failed to offer any evidence that any of the victims of the bites which presaged this matter were under the influence of drugs or alcohol at the time of any of the attacks, or that any had been tested for such substances. Espinoza's speculation that any drug or alcohol use triggered the attacks is unsubstantiated by evidence of any kind. For the same reason, we decline to admit the print outs of news stories or summaries, which do not appear to have any bearing on the events which led to this proceeding. While we admit the declaration of Virginia Espinoza, the absence of any live testimony, either in the proceedings before the hearing officer or here, make them essentially hearsay with little value or weight.

B. IVHS's Case.

In support of the hearing officer's decision, the following witnesses testified: Kaylie Arola (one of the victims), Valerie Espinoza (mother of Kaylie and step-mother of victim Chloe Arola and a witness to the events), IVHS Officer Stephanie Aldaco and IVHS Officer Robert Gonzalez. Each of these witnesses credibly testified to the events which are detailed in the hearing officer's Findings and Decision.

C. Espinoza's Rebuttal.

Mr. Espinoza clearly cares deeply for his dogs. However, Espinoza failed, in either his own testimony or in contradictory evidence or rebuttal, to undermine or challenge the substance of the critical events. Indeed, he never offered credible evidence that the bite incidents which form the basis for the decision appealed did not occur or were not attributable to his dogs. His efforts to blame the victims who were bitten have no evidentiary support. Assumptions, innuendoes and speculation fueled Espinoza's entire argument. While he loves his dogs, which is commendable, he failed to demonstrate that the hearing officer's decision is incorrect or that the conditions imposed are unreasonable or cannot be implemented.

III. The Imposed Penalty and Conditions.

The hearing officer declared Rhianna to be Vicious Dog, determining that she must be humanely

ethanized to protect the public health and safety. Phat Girl, Gilligan and Zeus were all declared Dangerous Dogs under the law, requiring that they may be kept – whether by Espinoza or someone else -- only if certain conditions are met. Espinoza offered no evidence or argument that the conditions imposed by the hearing officer on Espinoza in order to keep Phat Girl, Gilligan and/or Zeus on his property were infeasible, unreasonable, or impracticable. Nor did he challenge the time period in which the required conditions must be met in order to maintain custody of Gilligan and Zeus or to have Phat Girl returned to his or another’s custody. Finally, he failed to challenge the duration of Dangerous Dog designations for Phat Girl, Gilligan or Zeus.

IV. Determination.

The City Council adopts the hearing officer’s factual findings and upholds the decision of the Hearing Officer to declare Rhiana a Vicious Dog and Phat Girl, Gilligan and Zeus to be Potentially Dangerous. Further, the City Council upholds the determination that Rhiana should be humanely euthanized and the conditions imposed for retention/return of Gilligan, Zeus and Phat Girl should be fully implemented as set forth in the Hearing Findings and Decision dated September 29, 2025. These conditions apply whether Espinoza wishes to take/retain custody of the dogs or whether they are housed elsewhere.







SUMMARY

The Quarterly Treasurer's Report provides an overview of the City's cash and investment holdings as of December 31, 2025. The report confirms compliance with the City's investment policy as set forth in Administrative Regulation Number 215, the Statement of Investment Policy, and the State of California's Government Code (GC) Section 53646.

RECOMMENDATION

That the City Council receive and file the Quarterly Treasurer's Report for the period ending December 31, 2025.

DISCUSSION

The attached Treasurer's Report is provided to the City Council per the City of La Verne Administrative Regulation Number 215, Investment Policy, and as provided under the State of California's Government Code (GC) Section 53646. GC 53646 provides that a quarterly report, or monthly if legislatively elected, to be submitted to the City Council detailing the City's cash and investments, a statement of compliance with the Investment Policy, and confirmation of the City's ability to meet pooled expenditure requirements for the next three months.

Pooled Cash and Investment Structure

The City holds cash and investments in a pooled cash account to efficiently manage and invest available funds. Rather than each fund maintaining separate bank and investment accounts, all cash is combined (or "pooled") into a single treasury account.

This approach allows the City to:

- Maximize investment returns by investing larger combined balances.
- Simplify cash management and reduce administrative costs.
- Ensure liquidity to meet obligations across all funds.

At quarter-end, the City allocates interest and investment income back to each fund based on its proportionate share of the total cash balance in the pool, ensuring each fund receives its fair portion of earnings.

Portfolio Summary

As of the reporting date, the City's total cash and investments amount to \$128,129,634, with a

market value of \$103,805,866. The significant variance between par value and market value is primarily due to agency securities, which have a par value of \$48.9 million but a market value of \$25.2 million. This variance reflects rising interest rates, which reduce the present value of future cash flows for fixed-income securities. Because these securities are held to maturity and not intended for sale, the unrealized losses have no impact on the portfolio's realized returns or liquidity.

Investment Composition

The investment portfolio is structured to prioritize safety, liquidity, and yield and is divided into two primary categories:

On-Call Deposits:

Totaling \$29,862,634, these funds are held in various checking accounts and liquid investment pools to ensure immediate availability. Notable balances include Local Agency Investment Fund (\$13.13M) and LA IMPACT in Local Agency Investment Fund (\$7.17M).

Long-Term Investments:

Totaling \$98,267,000 in par value with a market value of \$73,943,232, these holdings include agency securities, U.S. Treasuries, municipal and corporate bonds, asset-backed securities (ABS), and certificates of deposit (CDs).

Agency securities, U.S. Treasuries, and corporate bonds form the largest components of the portfolio, with market values of \$25.22M, \$21.96M, and \$21.65M respectively. Weighted average yields remain competitive, with many investments offering yields above 4%.

Investment Policy Compliance

The portfolio complies with all policy constraints related to credit quality, issuer limits, maturity limits, and sector allocations. The City Treasurer certifies that all investments conform to the current Investment Policy and applicable state regulations.

Conclusion

The City's investment strategy remains prudent and diversified. The Treasurer's Office continues to closely monitor interest rates and market trends to adjust the investment mix as necessary, while maintaining the primary objectives of safety, liquidity, and yield.

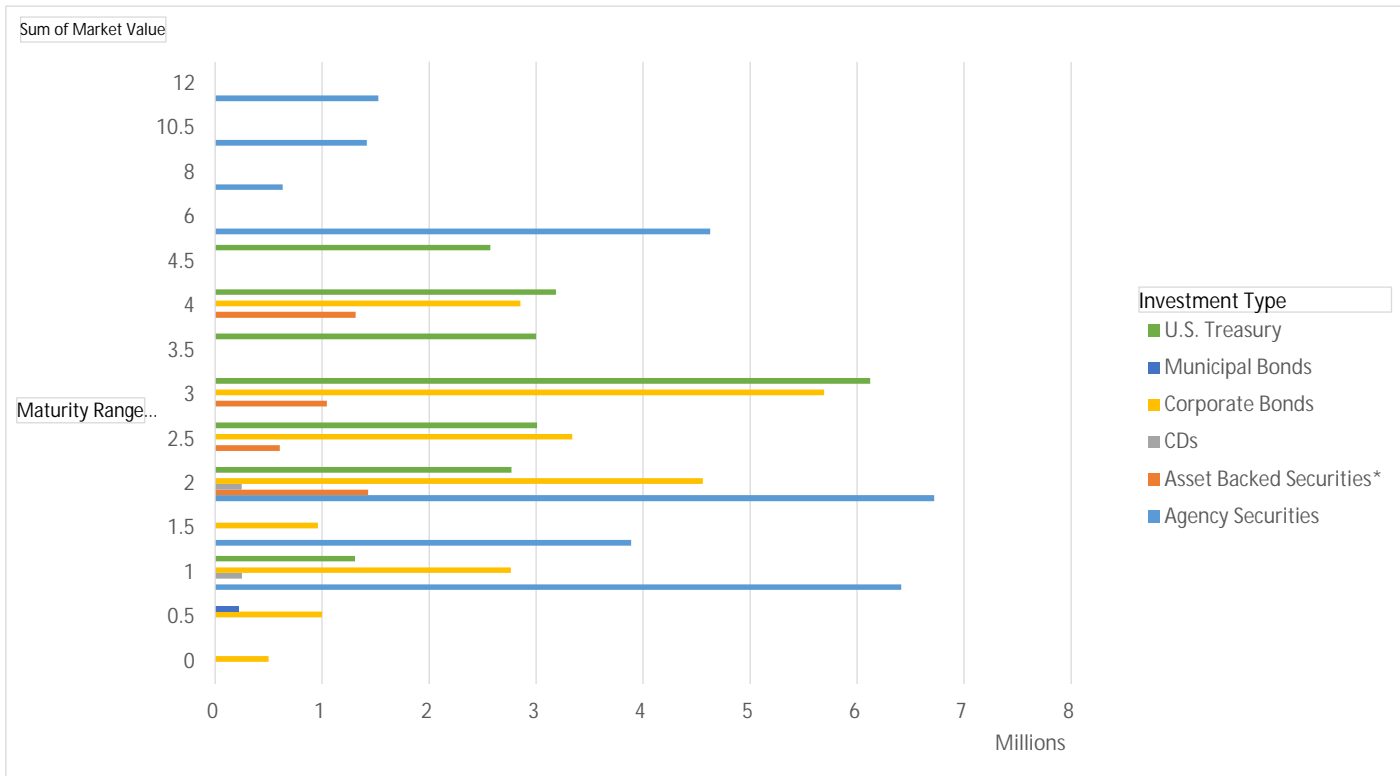

SUBJECT: DECLARATION OF INTENTION TO PROVIDE WEED ABATEMENT ON SPECIFIC PROPERTIES.

SUMMARY

Each year, the County of Los Angeles Department of Agricultural Commissioner/Weights & Measures conducts inspection for weeds, brush, rubbish, and refuse on public and private property that may be considered a seasonal and recurrent nuisance. A list of properties is provided to the City for review. City council is then required to declare its intention to provide for this abatement and set a public hearing for affected property owners to register objections to said abatement.

RECOMMENDATION

That the City Council adopt a Resolution titled, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, CALIFORNIA, DECLARING THAT WEEDS, BRUSH, RUBBISH AND REFUSE UPON OR IN FRONT OF SPECIFIED PROPERTY IN THE CITY ARE A SEASONAL AND RECURRENT PUBLIC NUISANCE AND DECLARING ITS INTENTION TO PROVIDE FOR THE ABATEMENT THEREOF" declaring the intention to provide for the abatement of weeds, brush, rubbish and refuse and setting a public hearing for Tuesday, February 17, 2026, at 6:30 p.m.

DISCUSSION

A number of private and public properties have been declared to be a fire hazard, and therefore, a public nuisance due to overgrowth of weeds or brush or the presence of rubbish or other flammable materials. The County of Los Angeles Department of Agricultural Commissioner/Weights & Measures has been designated to inspect the properties, provide notice to the property owners, and perform weed abatement services. A list of impacted properties is included as an attachment to this report. The process as permitted by California Government Code Section 39560 to 39588 requires that the City Council first declare its intention to provide for the abatement and set a public hearing to allow affected property owners to register objections to the abatement of the weeds, brush rubbish and refuse. All properties subject to a weed abatement letter are provided notice and many of the properties typically abate the nuisance on their own. There are several City properties listed on the attached list and these known properties are part of the City's fuel modification program in which the County abatement contractor is the least costly means of fuel modification or City crews have not yet abated the property due to the timing of this process, but will before further actions at a later date.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, CALIFORNIA,
DECLARING THAT WEEDS, BRUSH, RUBBISH AND REFUSE UPON OR IN FRONT OF
SPECIFIED PROPERTY IN THE CITY ARE A SEASONAL AND RECURRENT PUBLIC
NUISANCE AND DECLARING ITS INTENTION TO PROVIDE FOR
THE ABATEMENT THEREOF**

THE CITY COUNCIL OF THE CITY OF LA VERNE DOES RESOLVE AS FOLLOWS:

BE IT RESOLVED THAT, pursuant to the provisions of Title 4, Division 3, Part 2, Chapter 13, Article 2, of the California Government Code, Sections 39560 to 39588, inclusive, and evidence received by it, the City Council of the City of La Verne specifically finds:

SECTION 1. That the weeds, brush, or rubbish growing or existing upon the streets, sidewalks, or private property in the city attain such large growth as to become, when dry, a fire menace to adjacent improved property, or which are otherwise noxious, dangerous, or a public nuisance.

SECTION 2. That the presence of dry grass, stubble, refuse, or other flammable materials are conditions which endanger the public safety by creating a fire hazard.

SECTION 3. That by reason of the foregoing fact, the weeds, brush, rubbish, dry grass, stubble, refuse, or other flammable material growing or existing upon the private property hereinafter described, and upon the streets and sidewalks in front of said property constitute a seasonal and recurrent public nuisance and should be abated as such.

SECTION 4. That the private property, together with the streets and sidewalks in front of same herein referred to, is more particularly described as follows, to wit: That certain property described in the attached list hereto and by this reference made a part hereof as though set forth in full at this point.

BE IT THEREFORE RESOLVED, pursuant to the findings of fact, by this Council heretofore made, that the weeds, brush, rubbish, dry grass, stubble, refuse, or other flammable material in and upon and in front of the real property hereinbefore described constitute and are hereby declared to be a seasonal and recurrent public nuisance which should be abated. The Agricultural Commissioner/Director of Weights and Measures, County of Los Angeles, is hereby designated the person to give notice to destroy said weeds, brush, rubbish, dry grass, stubble, refuse, or other flammable material and shall cause notices to be given to each property owner by United States Mail and said notice shall be substantially in the following form to wit.

NOTICE TO DESTROY WEEDS, REMOVE BRUSH, RUBBISH AND REFUSE

Notice is hereby given that on February 2, 2026, the City Council of the City of La Verne passed or will pass a resolution declaring noxious or dangerous vegetation including weeds, brush, tumbleweeds, sagebrush, and chaparral or rubbish and refuse were growing or occurring upon or in front of said property on certain streets in said city or unincorporated area of the County of Los Angeles, and more particularly described in the resolution, and that they constitute a public nuisance which must be abated by the removal of said noxious or dangerous vegetation, rubbish and refuse. The resolution further declares that, if not abated, the vegetation and/or rubbish and refuse may be removed, and the nuisance abated by County authorities in which case the cost of removal shall be assessed upon the land from or in front of which the noxious or dangerous vegetation, rubbish and refuse are removed. Such cost will constitute a special assessment against such lots or lands. Reference is hereby made to said resolution for further particulars. In addition, the Board of Supervisors of the County of Los Angeles authorized and directed the Agricultural Commissioner to recover its costs of details. All property owners having any objections to the proposed removal of noxious or dangerous vegetation, rubbish and refuse and the recovery of inspection costs, are hereby notified that they may attend a hearing of the City Council of said City to be held at 3660 D Street, La Verne, CA 91750, in the Council Chambers on Tuesday, February 17, 2026 at 6:30 p.m. where their objections will be heard and given due consideration. If the property owner does not want to present objections to the proposed removal of the noxious or dangerous vegetation including weeds, brush, tumbleweeds, sagebrush, and chaparral or rubbish and refuse, or the recovery of inspection costs, the owner need not appear at the above mentioned hearing.

BE IT FURTHER RESOLVED that the Agricultural Commissioner is hereby authorized and directed to recover its costs of inspection of the properties hereinabove described in a manner consistent with prior action of the Board adopting a fee schedule for such inspections. The recovery of these costs is vital to the ongoing operation governing the identification and abatement of those properties that constitute a seasonal and recurrent public nuisance and endanger the public safety.

BE IT FURTHER RESOLVED that the 17th day of February, 2026, at the hour of 6:30 p.m. of said day is the day and hour, and the meeting room of the City Council of the City of La Verne in the City Hall in the City of La Verne is fixed by this City Council as the place when and where any and all property owners having any objections to the aforesaid proposed removal of weeds, brush, rubbish, dry grass, stubble, refuse, or other flammable material may appear before the City Council and show cause why said weeds, brush, rubbish, dry grass, stubble, refuse, or other flammable material should not be removed in accordance with this resolution, and said objections will then and there be heard and given due consideration; and

BE IT FURTHER RESOLVED that the notices to destroy weeds, brush, rubbish, dry grass, stubble, refuse or other flammable material hereinbefore referred to shall be mailed by said Agricultural Commissioner/Director of Weights and Measures at least ten days prior to February 17, 2026.

SUMMARY

City Council is asked to adopt an ordinance that reduces the minimum density from 38 dwelling units per acre (du/ac) to 20 du/ac to better align with current economic conditions and encourage new investment within the Mixed-Use 1 district of the Old Town La Verne Specific Plan area.

RECOMMENDATION

That the City Council adopt an Ordinance, entitled "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA VERNE, CALIFORNIA, AMENDING THE OLD TOWN LA VERNE SPECIFIC PLAN TO REVISE THE MINIMUM DENSITY REQUIREMENT IN THE MIXED-USE 1 LAND USE DISTRICT FROM 38 TO 20 DWELLING UNITS/ACRE" and find that the adoption is exempt from the California Environment Quality Act pursuant to the common sense exemption of CEQA Guidelines section 15061(b)(3).

DISCUSSION

As presented at the last meeting, due to changes in market conditions and the feasibility of high-density residential development, the City's minimum residential density requirement for the Mixed-Use 1 district in the Old Town La Verne Specific Plan area has become a barrier to development. The proposed ordinance reduces the minimum density from 38 dwelling units per acre (du/ac) to 20 du/ac to better align with current economic conditions and encourage new investment within the Mixed-Use 1 district of the Old Town La Verne Specific Plan area.

This item was introduced for first reading at the January 20, 2026, meeting and approved by a vote of 5-0.

FISCAL ANALYSIS

Approval of this item will have no direct financial impact.

ENVIRONMENTAL ANALYSIS

Making Determination of Exemption from the California Environmental Quality Act Pursuant to the Common Sense Exemption of CEQA Guidelines Section 15061 (B) (3) and Second Reading and Adoption of "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA VERNE, CALIFORNIA, AMENDING THE OLD TOWN LA VERNE SPECIFIC PLAN TO REVISE THE MINIMUM DENSITY REQUIREMENT IN THE MIXED-USE 1 LAND USE DISTRICT FROM 38 TO 20 DWELLING UNITS/ACRE.", Page 2

The ordinance is exempt from CEQA under CEQA Guidelines Section 15061(b)(3) (Common Sense Exemption) because it reduces the minimum density requirement, does not increase development potential, and does not create a reasonably foreseeable environmental impact.

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LA VERNE,
CALIFORNIA, AMENDING THE OLD TOWN LA VERNE SPECIFIC PLAN TO
REVISE THE MINIMUM DENSITY REQUIREMENT IN THE MIXED-USE 1 LAND USE
DISTRICT FROM 38 TO 20 DWELLING UNITS/ACRE**

WHEREAS, Government Code Section 65300 *et seq.* requires the City of La Verne (“City”) to adopt and maintain a General Plan that contains certain elements, describes its long-term goals, and develop policies and programs to achieve those goals; and

WHEREAS, in June 2024, the City approved a mixed-use housing development project in the Old Town La Verne Specific Plan area for 1941 White which provided for a density of approximately 77 units per acre; and

WHEREAS, in November 2024, the City Council adopted an Urgency Ordinance establishing a minimum density requirement of 38 dwelling units/acre for the Mixed-Use 1 and 2 land use districts in order to help meet the City’s housing obligations as set forth in the 2021-2029 Housing Element and to help support the City’s Enhanced Infrastructure Financing District; and

WHEREAS, in February 2025, the City Council adopted Ordinance No. 25-1129 which imposed a minimum density requirement of 38 dwelling units/acre for the Mixed-Use 1 and 2 land use districts; and

WHEREAS, for a number of reasons, high-density multi-family housing has slowed down in the State in the past year and has become more difficult to finance and more costly to build; and

WHEREAS, symptomatic of the change in the economics has caused the developer of 1941 White to determine that it is no longer financially feasible to move forward with the project and there has been no interest from buyers in developing this project; and

WHEREAS, one of the top real estate brokers (Colliers) has informed the City that the difficulty in building new market-rate apartments at this time has to do with the cost of construction exceeding the value of existing market-rate properties as rising interest rates, high material costs, and labor shortages have pushed total development costs to historic highs; and

WHEREAS, there is still a market for the development of lower-density projects; and

WHEREAS, the City Council recognizes that by creating a minimum density of 38 dwelling units/acre in order to spur development, it unwittingly created a situation where development has actually been stymied; and

WHEREAS, the Mixed-Use 1 land use district has a lower maximum residential density that the Mixed-Use 2 land use district; and

WHEREAS, the City Council has determined that it is in the best interests of the City to reduce the minimum density allowed in the Mixed-Use 1 land use district in order to spur development; and

WHEREAS, this Ordinance does not impact the maximum density that may be built on any lot in the Mixed-Use 1 land use district; and

WHEREAS, on December 10, 2025 the Planning Commission held a duly noticed public hearing on this Ordinance at which time it considered all evidence presented, both written and oral; and

WHEREAS, after the close of the public hearing the Planning Commission approved a resolution recommending that the City Council adopt this Ordinance and find that the Ordinance is exempt from CEQA; and

WHEREAS, on January 20, 2026, the City Council held a duly noticed public hearing on this Ordinance for Introduction and First Reading.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA VERNE DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. Findings. The Whereas clauses set forth above are true and correct and incorporated herein as findings of fact.

SECTION 2. The Old Town La Verne Specific Plan is hereby amended as follows:

SECTION 3. CEQA. This Ordinance is exempt from CEQA under the “common sense exemption” of CEQA Guidelines Section 15061(b)(3). The Ordinance only reduces the minimum number of dwellings per acre but does not change the total amount of development that is allowed.

SECTION 4. Severability. If any section, subsection, subdivision, paragraph, sentence, clause or phrase of this ordinance, or any part thereof is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance or any part thereof. The City Council hereby declares that it would have passed each section, subsection, subdivision, paragraph, sentence, clause or phrase thereof, irrespective of the fact that any one or more section, subsection, subdivision, paragraph, sentence, clause, or phrase be declared unconstitutional.

SECTION 5. Effective Date. This Ordinance shall take effect on the 31st day after passage.

SECTION 6. The City Clerk shall certify to the adoption of this Ordinance.

SUBJECT: UPDATE AND DISCUSSION ON INCREASED WIRELESS/CELLULAR COVERAGE IN NORTH LA VERNE.

SUMMARY

Due to fair to poor wireless telecommunications coverage in the North La Verne residential neighborhoods and the potential public safety impacts from reduced connectivity, the City Council was asked to review how to increase wireless connectivity in the North La Verne area. The City Council therefore directed that a review be provided to the City Council and Staff is requesting direction from the City Council based on this update.

RECOMMENDATION

That the City Council receive and file this report and provide Staff appropriate direction to encourage greater wireless coverage in North La Verne.

DISCUSSION

Wireless telecommunications coverage in the area of North La Verne, defined herein as residential neighborhoods north of Baseline Road and specifically areas adjacent to Golden Hills Road, have various degrees of coverage as identified by available coverage maps. Coverage in general depends greatly on the carrier at the present time, with AT&T and T-Mobile having greater coverage due to cell towers located at the clubhouse of the former Sierra La Verne Country Club and Verizon having poor or no coverage in areas due to current placement of towers or small cell wireless equipment.

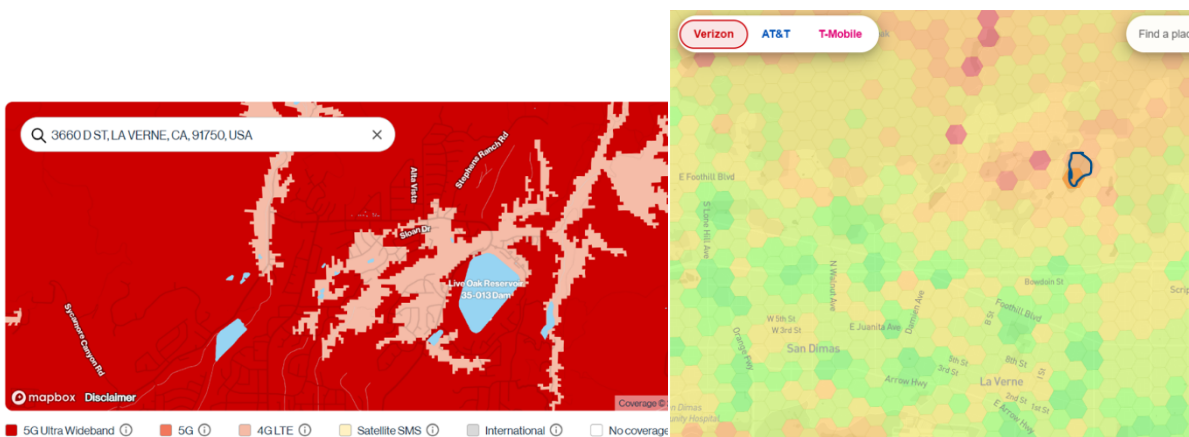
Small cell wireless facilities, otherwise known as small cells, are just what the name implies: sites having smaller wireless radios and antennas than macro cell sites (such as the typical wireless cell tower). Small cell wireless facilities have a range that varies from a few hundred feet to upwards of 1,000 feet, depending on terrain and the radio frequencies used. Located typically on streetlights, solo poles, or other infrastructure near the public right of way, these lower power facilities primarily add capacity in high-traffic areas, dense urban areas, and suburban communities. The increase in the use of smartphones, wireless tablets, and streaming devices, has increased the need for more wireless bandwidth to accommodate the need for upload/download speeds and greater data flow making the addition of small cells critical to today's technological environment. While they are not a substitute for macro cell sites, they do greatly assist in areas where a macro cell may not be practical or possible. Small cell facilities can be processed at the staff level through an encroachment permit, while macro cells (cell towers) require a Conditional Use Permit through the Planning Commission.

The critical infrastructure required for increased small cell wireless deployment is a fiber

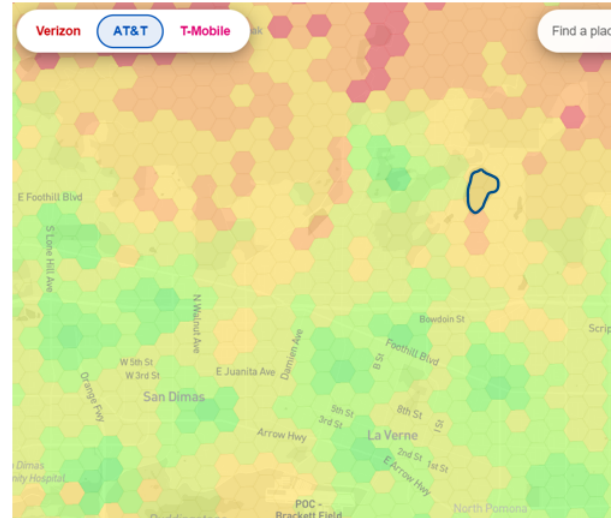
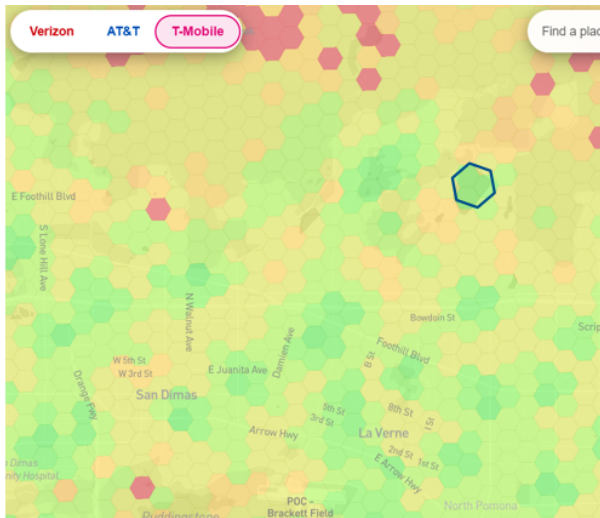
connection. Fiber is necessary to connect the small cell to the broader network allowing it to handle high-speed data traffic. Typical fiber installation is via aerial utility poles. The thicker cables lowest on a utility pole are cable, fiber, and telephone lines while the higher levels are transmission and then distribution (high voltage) electrical lines. In areas such as North La Verne, which were primarily developed after under grounding of utilities was required by local governments, the absence of above ground utility poles greatly increases the cost to install fiber lines. It is primarily for this reason, the lack of aerial fiber connection, as to why wireless coverage in North La Verne is deficient.

While cell coverage differs in North La Verne based on carrier, it is primarily because two carriers, AT&T and T-Mobile, have macro cells located at the clubhouse at the former Sierra La Verne Country Club. The tower currently operated by T-Mobile was built in 2008 and the one operated by AT&T was built in 2015. A third tower, applied for by Verizon in 2015, had permits issued in 2016 which expired in 2017. A new proposal for Verizon came in 2019, was approved by the Planning Commission in 2020, but those permits expired in 2021 and the tower was never built. The expiration of those permits are rumored to have been due to the pending sale of the golf course and the previous owner not wanting to complicate the sale. At this time, only the two towers are in place explaining the limited coverage by Verizon.

Cell coverage maps can generally be found online and typically within a carrier's website if not on the website of independent firms using data from the Federal Communications Commission (FCC). The following is a Verizon coverage map (<https://www.verizon.com/coverage-map/>) for the North La Verne area with Live Oak Reservoir providing a frame of reference and a second Verizon coverage map to provide comparison to coverage maps for AT&T and T-Mobile located on the next page (<https://coveragecritic.com/coverage-model/best-cell-phone-coverage-plans-in-la-verne-ca/>).

Opportunities for Increased Coverage

Clearly, the best opportunity for increased coverage is gaining a third tower at the Sierra La Verne Country Club or adjacent area such as a city-owned property or park. However, in all cases, access to fiber may be an impediment. For this reason, the City reached out to Crown Castle, a nationwide provider of shared communications infrastructure (cell towers, small cells, and fiber), last year to inquire about fiber installation and the City Council on April 7, 2025, approved a Memorandum of Understanding with Crown Castle for their new Rapid Connect fiber installation. While this was not an award of a construction contract or even an agreement to install fiber, it was an understanding that Crown Castle could install fiber up Wheeler Avenue from the Oak Mesa Park area to Golden Hills Road and east to Esperanza Drive. This fiber installation, while making it easier for small cell facilities for any telecommunications carrier, is dependent on a small cell carrier working with Crown Castle to fund the construction. The City has reached out to Crown Castle to inquire about the cost of the fiber installation using the Rapid Connect system as a means to "build it" and see if small cell carriers will then come to take advantage of the fiber option. Rough estimates for typical fiber installations (trenching or boring under streets) range from \$40,000 to \$60,000 per mile based on method of installation and location situation. The installation of a Rapid Connect system, which is a small 1 to 1.5 inch cut in the pavement, is estimated to be significantly less.

Additionally, in the last several months, the City has been in communication with Verizon wireless for the installation of eight small cell facilities, with four being north of Baseline Road and one of the four being slightly northeast of Live Oak Reservoir. The City received a draft Master License Agreement from Verizon in early December 2025, and we are currently working with Verizon to finalize the agreement for the locations in order to bring it to the City Council for consideration within the next few months. These small cell facilities are part of Verizon's business plan and not a result of the City reaching out to Verizon. However, we are working with the Verizon representatives regarding additional placement of small cell facilities along Golden Hills Road in order to further reduce the coverage gap for Verizon coverage based on resident concerns. We are hoping to take advantage of the earlier agreement with Crown

Castle for their Rapid Connect installation but also understand that all carriers have their own procurement processes and bidding practices to follow. Regardless, the prospect of increased Verizon coverage in the North La Verne area in the near future is positive.

Other Factors for Consideration

While Planning Commissions and City Councils may receive public testimony on health concerns related to radio frequency (RF) exposure, decisions cannot be made based on those concerns. The 1996 Federal Telecommunications Act expressly preempts state and local government regulation of the placement, construction, and modification of personal wireless service facilities on the basis of the environmental effects of RF emissions to the extent that such facilities comply with the FCC's regulations concerning such emissions (47 U.S.C. §332(c)(7)(B)(iv)). An applicant seeking to install a small wireless facility or macro cell will be required to affirm compliance with the FCC RF exposure requirements, but the FCC remains the exclusive agency for resolving non-compliance.

Finally, it is clear that the issues affecting the placement of a third macro cell tower at Sierra La Verne Country Club greatly hindered increased wireless coverage in North La Verne. Through all of this, it is important to note that cities do not build telecommunication infrastructure, but through our regulations or processes, we can delay implementation. In order to provide the best service to our residents, it is encouraged that we continue to provide a welcoming process for increased use of telecommunications and ensure our residents have access to the best of their ability and service provider.

Council Direction Moving Forward

At this time, Staff is requesting City Council direction to continue working with Verizon representatives to expand the amount of small cell facilities in the North La Verne area beyond the planned eight (8) sites proposed. This direction includes getting estimates for fiber installation in the North La Verne area for Crown Castle's Rapid Connect system or other non-aerial methods to provide for further small cell facilities in which the City could provide upfront costs (build it and they will come approach) as well as facilitating the potential of locating a third macro cell tower at or near the current two towers (or co-locating if possible) in order to increase wireless coverage. It is understood that any agreement or planned expenditure of City funds will require a return to the City Council for authorization based on specific outcomes.

FISCAL ANALYSIS

The provision of information and discussion regarding this issue does not have a financial impact. Future agenda items may have financial impacts and those impacts will be discussed as part of any future City Council action.

ENVIRONMENTAL ANALYSIS

No environmental analysis is required for this discussion and taking direction from the City Council. In the future, it is important to note that the approval and construction of new wireless communication facilities are generally categorically exempt from the California Environmental Quality Act (CEQA) under several provisions to include:

- CEQA Guidelines Section 15303 (Class 3 – New Construction or Conversion of Small Structures), which includes construction and location of limited numbers of new, small facilities or structures, including utility extensions and accessory structures; and/or

- CEQA Guidelines Section 15304 (Class 4 – Minor Alterations to Land), which includes minor trenching and backfilling where there is no removal of mature, scenic trees; and/or
- CEQA Guidelines Section 15301 (Class 1 – Existing Facilities), if collocation or replacement on an existing structure; and/or
- CEQA Guidelines Section 15311 (Class 11 – Accessory Structures) for placement of small accessory equipment.

Additionally, it is important to note that wireless facilities are designed to comply with all applicable Federal Communications Commission (FCC) regulations for radio frequency (RF) emissions. Under federal law, local agencies are preempted from denying wireless facilities on the basis of environmental effects of RF emissions so long as the facility complies with FCC standards (47 U.S.C. § 332(c)(7)(B)(iv)).
